

resident if, for more than 183 days in one year (calendar year from January to December):

- He/she is enrolled in the Record of Italian resident population (Anagrafe); or
- He/she has his/her domicile in Italy; or
- His/her residence is located in Italy, pursuant to art. 43 of the Italian Civil Code or
- He/she is present in Italy physically;

If only one of the above four conditions is met for more than 183 days, you are considered an Italian tax resident.

On the contrary, if none of the above four conditions is met for more than 183 days you are considered a non-Italian tax resident.
